- FOR AN ACT relating to tobacco; to amend sections 28-1429.01
 and 28-1429.02, Reissue Revised Statutes of Nebraska; to
 prohibit the dispensing of tobacco products by vending
 machines; and to repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 28-1429.01, Reissue Revised Statutes

- 2 of Nebraska, is amended to read:
- 3 28-1429.01 The Legislature finds that the incumbent
- 4 health risks associated with smoking tobacco products have been
- 5 scientifically proven. The Legislature further finds that the
- 6 growing number of minors who start smoking is staggering and even
- 7 more abhorrent are the ages at which such children begin this
- 8 deadly habit. The Legislature has established an age restriction on
- 9 the use of tobacco products by minors. To ensure that the use of
- 10 tobacco products among minors is discouraged to the maximum extent
- 11 possible, it is the intent of the Legislature to ban the use of
- 12 vending machines and similar devices to dispense tobacco products
- 13 in facilities, buildings, or areas which are open to the general
- 14 public within Nebraska.
- 15 Sec. 2. Section 28-1429.02, Reissue Revised Statutes of
- 16 Nebraska, is amended to read:
- 17 28-1429.02 It is (1) Except as provided in subsection (2)
- 18 of this section, it shall be unlawful to dispense cigarettes or
- 19 other tobacco products from a vending machine or similar device.
- 20 Any person violating this section shall be is guilty of a Class
- 21 III misdemeanor. In addition, upon conviction for a second offense,
- 22 the court shall order a six-month suspension of the offender's
- 23 license to sell tobacco if any and, upon conviction for a third or
- 24 subsequent offense, the court shall order the permanent revocation
- 25 of the offender's license to sell tobacco if any.
- 26 (2) Cigarettes or other tobacco products may be dispensed
- 27 from a vending machine or similar device when such machine or

- 1 device is located in an area, office, business, plant, or factory
- 2 which is not open to the general public or on the licensed premises
- 3 of any establishment having a license issued under the Nebraska
- 4 Liquor Control Act for the sale of alcoholic liquor for consumption
- 5 on the premises when such machine or device is located in the same
- 6 room in which the alcoholic liquor is dispensed.
- 7 (3) Nothing in this section shall be construed to
- 8 restrict or prohibit a governing body of a city or village
- 9 from establishing and enforcing ordinances at least as stringent as
- 10 or more stringent than the provisions of this section.
- 11 Sec. 3. Original sections 28-1429.01 and 28-1429.02,
- 12 Reissue Revised Statutes of Nebraska, are repealed.
